

Resident Educator 2 Year EPP Survey: Measure 1 Completer Effectiveness and Impact on P-12 learning and development

The Ohio Department of Education administers a survey aligned with the Ohio Standards for the Teaching Profession (OSTP), Ohio licensure requirements, and elements of national accreditation to gather information on alumni satisfaction with the quality of their educator preparation programs. The Ohio Department of Education sends an invitation to all Ohio Resident Educators to complete the survey in the fall semester of year 2 of the Resident Educator program. Individuals who have completed their preparation and graduated from an EPP (Educator Preparation Program) in Ohio and obtained employment in an K-12 school in Ohio must complete the Resident Educator Program. The Resident Educator Program supports new teachers transitioning into the field through mentorship and support. The Ohio Department of Education publishes this survey data in each EPP's annual performance report, comparing each institution to the state average. This Resident Educator 2 Year Survey directly mirrors the survey provided to all pre-service educators during their final semester and student teaching experience.

Due to our N<10 response number to the state's survey, our EPP sends the state survey questions directly to our graduates to collect our own data. We value this data from our education graduates who have been in the field for 2 years and use this, along with the Pre-Service Teacher Survey data to identify strengths and areas of improvement for our education program. See documentation of our continuous improvement documentation to see how we use this data, and other data, are used to make ongoing improvements to our education program.
